- 3. No change in the schedule of Undergraduate (other semesters) will commence as per earlier schedule i.e. 04.08.2020.
- 4. If the number of teaching days falls less than 180 days (90 days in each semester) in the academic session 2020-21 due to some unforeseen reasons, it would be the responsibility of each Department/Institute/ College to make good the loss by arranging extra classes.
- 5. The Principals/Directors of the affiliated colleges/Institutes shall follow the guidelines of the State Government regarding admission schedule and they are also authorized to make minor changes/adjustments according to their local conditions at their own level, keeping in view, the condition of minimum 90 days in each semester and directions from the State Government.
